



Invitation for Bids (IFB)

Supply, installation & commissioning of 15 No's of Stabilized Electro Optical Devices (EODs) on board Sri Lanka Navy ships/ craft

- The Chairman, Standing Cabinet Appointed Procurement Committee on behalf of the Sri Lanka Navy (SLN), now invites sealed bids from eligible and qualified bidders for the following procurement as specified in the bidding documents.
Supply, Installation & Commissioning of 15 No's of Stabilized Electro Optical Devices (EODs) on-board Sri Lanka Navy ships / craft and proving to the satisfaction of Sri Lanka Navy.
- The supplier shall offer the system with guaranteed performance under operating conditions specified at technical specifications. The supplier shall agree to supply all materials, equipment, drawings, design, technical literature and supplier to undertake the installation work and commissioning of systems.
- Bidding process will be conducted through International Competitive Bidding (ICB).
- Bids will be invited from Bidders that possess at least 10 years' experience in manufacturing Stabilized Electro Optical Devices (EODs) and Local Bidders should have at least 05 years period of business registration. Foreign Bidders shall quote through duly appointed (accredited) Local Agent and the Bidders shall comply following,
 - Aforesaid Local Agent shall have registered his/her business at least 05 years in Sri Lanka.
 - Bidder should provide OEM certificate for offered Electro Optical Devices (EODs).
 - Local bidders shall possess manufactures' authorization for bidding and should provide certification.
- Qualified bidders shall possess legal rights for the above procurement and the Bidder should possess valid business registration under Public Contract No. 03 of 1987 (for Local Bidders only). A copy of the certificate for Business Firm Registration should be submitted with the bidding document. Additional details are provided in the Bidding Documents and few important extractions of the Public Contract Act is as follows.

"any person who act as an agent or sub-agent, representative or nominee on behalf of any bidder, shall register himself and such public contract in accordance with the section 10 and shall furnish to the register the particulars required to be furnish under section 6"

"where any person is an agent, sub-agent, representative or nominee for or on behalf of a bidder, he shall first produce a certificate of his appointment as agent sub-agent, representative or nominee to the registrar before he registers himself and the public contract under this section.

Bidders are advised to present the registration certificate before purchasing the bidding document, according to the "public contracts act no 3 of 1987", if relevant.
- Eligible bidder should submit the Certification of International Standards on the compatibility of the product.
- Financial Capability and other qualification requirement: Average annual turnover of the Bidder shall not be less than equivalent to Sri Lankan Rupees (LKR) 750 Million in last five years.

- All bids must be accompanied by a "Bid-Security," to the value of Sri Lankan Rupees **twenty two (22) million** (LKR 22,000,000.00). The bid security (ITB 20.2) shall be an 'on demand unconditional Bank Guarantee' issued by a bank operating in Sri Lanka, approved by the Central bank of Sri Lanka. The bid security should be valid up to **18th April 2022**. Further it should be as per the format given.
- The decision taken by the Standing Cabinet Appointed Procurement Committee will be the final decision and the purchaser reserves the right to make any amendments.
