The Chairman, Standing Cabinet Appointed Procurement Committee (SCAPC) of the Ministry of Defence on behalf of the Secretary, Ministry of Defence (MOD) now invites sealed Bids from eligible and qualified Bidders to supply Tactical Radio Communication Equipment for Upgrading and Modernization of Sri Lanka Army Radio Communication System (stage 1).

The work consists of supply and to provide technical support to upgrade and modernize Sri Lanka Army Radio Communication system with tactical radios and related equipment and accessories listed at following, under stage 1.

2. Bidding will be conducted through International Competitive Bidding (ICB) Procedure and the project will be financed by the Government of Sri Lanka (GOSL) funds. Agreed conditions shall govern by the Sri Lankan Procurement Guidelines and Financial Regulations.

3. To be considered for evaluation and qualify for contract award, bidder shall not have been blacklisted and is required to bid for all items and total quantity of each item and relevant services as specified in the bidding documents. Partial bids shall be treated as non-responsive and shall be rejected.
4. To be eligible for contract award, local and foreign Bidders shall possess proven track record of five (05) years or more experience in supplying of Military Tactical Radio Communication systems. Documentary evidence to support foreign bidders' experience and track record shall be established with the Bid.
5. A Complete set of Bidding Documents in English Language are available and interested Bidders may purchase the Bidding Documents from 0900 hrs to 1500 hrs before 08. 04. 2020 in any working days except public holidays, Saturdays and Sundays on submission of a written application to **Accountant (Procurement) Ministry of Defence, Ground Floor, No: 15/5, Baladaksha Mawatha, Colombo 03, Sri Lanka** and upon a payment of a **non-refundable tender fee of Sri Lankan Rupees Three Hundred Thousand (LKR 300,000.00) in cash. Bidding documents may be inspected free of charge at the Ministry of Defence at the same** address.

7. **A Pre-Bid meeting will be held on 03/03/2020 at 1100 Hrs at Ministry of Defence, No:15/5, Baladaksha Mawatha, Colombo 03, Sri Lanka.**
8. Bids must be delivered on or **before 1100 Hrs on 09. 04. 2020 at the address; Accountant (Procurement), Ministry of Defence, No: 15/5, Baladaksha Mawatha, Colombo 03, Sri Lanka.** Late Bids and Bids sent electronically will not be accepted and will be rejected.
9. Bid shall be valid up to **06/08/2020(Hundred and twenty (120) days** from the date of deadline for submission of the Bids).
10. All Bids must be accompanied by Bid Security in the form of a **Bank Guarantee in the format given with the Bidding Document in the amount of Sri Lankan Rupees Forty Million, Nine Hundred Thousand (LKR 40,900,000.00) or an equivalent** amount in a freely convertible currency obtained from a bank operating in Sri Lanka approved by the Central Bank of Sri Lanka. Bid Security issued by a bank operating overseas is acceptable provided the Bid Security or bank guarantee is confirmed by a bank operating in Sri Lanka approved by Central Bank of Sri Lanka. This Bid Security shall be in the form of an unconditional, on demand bond and shall be valid up to **06/09/2020 (150 days after the bid opening).**
11. **Bids will be opened soon after closing at 1100 hrs on 09.04.2020 in the presence of Bidders'** authorized representatives (Bidders name, ID or Passport copy should submit 3 days before) who choose to attend in person at the office of Accountant (Procurement), Ministry of Defence, No:15/5, Baladaksha Mawatha, Colombo 03, Sri Lanka immediately after the deadline for submission of Bids.
12. The supply of Tactical Radio Communication equipment for upgrading and modernization of Sri Lanka Army Radio Communication system **(stage 1) should** be completed within the period of four months (04) from the date of signing the contract.
13. Ministry of Defence will not be responsible for any costs or any expenses incurred by the Bidders in connection with the preparation or delivery of Bids.
