Presidential address:

Mr. V.S. 'Atmanirbhar Bharat', he mentioned was about opening India's engagement for a greater global engagement wherein there is a larger role for small entrepreneurs, businesses, youngsters and all stakeholders to become part of a resilient supply chain.
