Message from the Director General

Dear Members and Friends,

Macroeconomic stability is of paramount importance for any country. In its Annual Report for 2015-16, released on August 29, 2016, RBI asserted that India has moved from one of the "fragile Five" countries to a country with "stable economy". This is reflected in moderate inflation and narrowing current account and fiscal deficits. The Report says the stable pace of expansion of the domestic economy has been outcome of 'private final consumption' portion of aggregate demand. This appears to have contributed over half of the overall GDP growth. Further, the rupee become one of the more stable emerging market currencies. Growth is good but growth with "stability" is better.

The Draft National Policy for Women 2016 made an attempt to identify the changing nature of gender roles in "the new millennium..... rapidly changing global and national scenario". The Draft also admitted that there is need for a working method for the MWCD to ascertain that all workplaces have instituted a complaints committee and there is a monitoring mechanism of complaints by the government. The challenge in policymaking is not in identifying "issues" but in the implementation of policy - we do hope this particular policy will be able to go that distance in the near future.

In the month of August, Bombay Chamber organized two events covering parts of the above mentioned issue. In addition, we organized a seminar on "Managing Risks & Liabilities in the Pharmaceutical Sector", conducted certificate course on "Network Security, Penetration Testing & Cyber Forensics" and also performed workshop on "Mock Mediation" to highlight commercial benefits of the alternative dispute resolution method. We also participated in mediation training conducted under the auspices of IICA at our facilities in Mumbai.

the vision for GST is a fully digitized administration, in the month of May, Chamber organized a full day seminar to provide insights into the IT strategy adopted by the GSTN, a not-for profit company which has been established jointly by the Central and State governments explicitly for this purpose. But to support members need to be updated on the Government's perspective on GST, i. e, how GST is going to put in place an indirect tax system with greater transparency and rationality, we are organizing a "Half-day Seminar on GST" on 22 September 2016.
