Message from the Director General

As we come to the end of FY 2016-17, it is time to reflect upon all that has happened over the past 12 months. Organizationally, it has been a year of continued focus on activities, membership and continuing efforts to understand and deal with the changes, challenges and development issues facing the economy including the effect of events such as Demonetization and its impact, post Trump America, Brexit fallout, fate of Euro zone, China slowdown, etc.

As far as domestic economy is concerned-going by the Gol's Economic Survey 2016-17 released on 31 January, 2017, a day before the presentation of the Union Budget 2017-18, the outlook has been "real GDP growth to be in the 6.75% to 7.5% range in 2017-18." More specifically, "given the high elasticity of Indian real export growth to global GDP, exports could contribute to higher growth next year, by as much as one percentage point." "Private consumption demand is expected to rebound, especially in housing and consumer durables and semi-durables. Regarding private investment, however, given the "twin balance sheet problem" (that is, of the lending institutions and the borrowing businesses), "private investment is unlikely to recover significantly from the levels of 2016-17." However, given the prevalent overall macroeconomic scenario and assuming a normal level of rains in this fiscal, it would not be unreasonable to conclude that the Indian economy is all set to register growth in excess of 7 per cent for the third year in succession.

This year has been a productive year for the Chamber with execution of hundred events and we are expected fifteen more events to be executed till end of March, 2017. In terms of highlights, the Chamber organized some important Flagship Events including The 180th Annual General Meeting of Bombay Chamber held on 13th May, 2016, which was presided by Chief Guest, Dr. Urjit Patel, Deputy Governor, Reserve Bank of India and Guest of Honour, Mr. C. P. Sharma, Chief Commercial Manager, Western Railways Additional Secretary, Govt. of India. While playing the role of 'Corporate as a Citizen', Bombay Chamber with support of 46 members contributed ~INR 1.9 Crores to the Central Railway at this event ,the amount represents over 25% of the cost of transporting drinking water from Miraj to Latur until June 15, 2016 via the "JALDOOT" train.
