



Message from the Director General

Dear Members,

As we go to press with our May issue of Newsletter, the Indian economy is brimming with positive momentum: Inflation is moderate, GDP growth continues to impress and fiscal & current account deficit remain under control. However, there are some areas of concern. According to the latest 'The Inclusive Growth and Development Report' published by the World Economic Forum, India, with a score of only 3.38, ranks 60th among the 79 developing economies on the Inclusive Development Index. This is despite the fact that India's growth in GDP per capita is among the top 10. Also, its debt-to-GDP ratio is high, the labor force participation rate is low and the informal economy is large.

Under this backdrop, Indian industry across sectors is ready for the July 1, 2017 roll-out of the "game-changing" Goods and Services Tax(GST). It is widely believed that the new taxation will help to bring increase in revenue by bringing more tax payers under the fold of formal economy. Also, even businesses will have to Digitize and this will help to bring transparency and create data for almost every monetary transaction in the economy, which in turn will expand tax base. Clearly, it is important to ensure that people everywhere have access to educational opportunities that provide the skills and knowledge needed to thrive in a Digital economy.

We, at the Bombay Chamber (who have several thousand member companies with approximately one third large and two thirds MSMEs) have undertaken and are undertaking various initiatives to provide our members Digital exposure. These include:
