#### Message from the Director General

#### Dear Members and Friends,

In its Third Bi-monthly Monetary Policy Statement, 2017-18, RBI reduced the policy repo rate under the liquidity adjustment facility (LAF) by 25 basis points from 6.25 per cent to 6.0 per cent with immediate effect.

On the domestic front, the document observed that, while inflation has fallen to a historic low, a conclusive segregation of transitory and structural factors driving the disinflation is still elusive. It has been noted that some of the upside risks to inflation have either reduced or not materialized - (i) the baseline path of headline inflation excluding the HRA impact has fallen below the projection made in June to a little above 4 per cent by Q4; (ii) inflation excluding food and fuel has fallen significantly over the past three months; and, (iii) the roll-out of the GST has been smooth and the monsoon normal. The Report also mentioned a normal and well-distributed south-west monsoon for the second consecutive year has brightened the prospects of agricultural and allied activities and rural demand.

We all are aware that though the economic contribution of agriculture to India's GDP is steadily declining with the country's broad-based economic growth, agriculture and allied sector accounted for 16% of the GDP, employed 52% of the total workforce and is still the largest economic sector and plays a significant role in the overall socio-economic development of India.
