
DFS Modifies ECLGS, Increases Collateral-Free Liquidity to Aid Aviation Sector

In a bid to aid the struggling civil aviation sector, the Department of Financial Services (DFS), Ministry of Finance, has modified the Emergency Credit Line Guarantee Scheme (ECLGS) to enhance the maximum loan amount eligibility for airlines under ECLGS 3.0 to 100% of their fund based or non-fund-based

loan outstanding as on the reference dates or Rs. 1,500 crore, whichever is lower. **READ MORE**
