

Dr. Raghunath Anant Mashelkar is known for his own world-class scientific research and his transformative leadership of institutions. He has been on the Board of Directors of India's leading industrial enterprises such as Reliance, Tata Motors, Hindustan Unilever, etc. He has been a member of External Research Advisory Board of Microsoft (USA), Advisory Board of VTT (Finland), Corporate Innovation Board of Michelin (France), Advisory Board of National Research Foundation (Singapore), among others. He has received a record of 47 honorary doctorates from universities around the world. He won the Lenovo Science Prize by The World Academy of Science, its highest science award. Dr. Mashelkar is the only living engineering scientists in India today, who has received the topmost honors, namely Fellow of Royal Society (FRS), Foreign Associate of US National Academy of Science (2005), Foreign Associate of US National Academy of Engineering and Foreign Fellow of US National Academy of Inventors. He was a member of the Scientific Advisory Council to the Prime Minister set up by successive governments for three decades. He is known for pioneering the IPR movement in India as also the 16 Mashelkar Committees that the Government set up, dealing with complex national policy issues. He received the Star of Asia Award at the hands of George Bush Sr, former President of USA. President of India honored Dr. Mashelkar with three of the highest civilian honors, namely Padmashri Padmabhushan and Padma Vibhushan


