Interested bidders may purchase a complete set of Bidding Documents in English language from the Procurement Branch, Ministry of Defence, Defence Headquarters Complex, Sri Jayewardenepura, Kotte (Tele- +94112390719, Fax- +94112390720, E-Mail (procurement@defence.lk) on the submission of a written application to the Chief Financial Officer I, Ministry of Defence, Defence Headquarters Complex, Sri Jayewardenepura, Kotte from dates mentioned in para 1, between 1000 hrs to 1500 hrs on every working day with effect from 21st October 2024 after paying the Non-refundable fee indicated against the procurement mentioned at para 1 above to the Secretary, Ministry of Defence, Defence Headquarters Complex, Sri Jayewardenepura, Kotte and the Bidding Document can be inspected (Free of charge) at Procurement Branch, Ministry of Defence, Defence Headquarters Complex, Sri Jayewardenepura, Kotte from 1000 hrs to 1500 hrs. The method of payment of the non-refundable deposit will be in cash.
- 4. Completed bid proposal must be couriered/ delivered to the address below, marked with Tender Identification Number on or before the stipulated time and date mentioned in above para 1 and late bids will be rejected. Bids will be opened immediately after the closing of the bids in the presence of the bidders/ bidders' representatives who choose to attend the Bid Opening, in person at the address below as per the referred time and dates mentioned above. No bidder or his representative will be permitted to attend the bid opening after the bid closing time.

Bid Security should be issued by any Commercial Bank operating on Sri Lanka, approved by the Central Bank of Sri Lanka with a counter guarantee and it should be addressed to the "Secretary to the Ministry of Defence" A sample copy of a bid security guarantee appeared in the Government Procurement Guideline 2006.
