Over 1 lakh 40 thousand recognized Start Ups in the country

DPIIT has recognised 1,40,803 entities as startups. Since the launch of Startup India initiative in 2016, the DPIIT-recognised startups have created over 15.53 lakh direct jobs till June 2024. Further, 67,499 DPIIT-recognised start-ups have at least one-woman director. The Government unveiled an Action Plan for Startups comprising of schemes and incentives envisaged to create a vibrant startup ecosystem in the country. The Action Plan comprises of 19 action items spanning across areas such as "Simplification and handholding", "Funding support and incentives" and "Industry-academia partnership and incubation".
