

## Public Holidays in 2026 for Maharashtra under Negotiable Instruments Act.

NOTIFICATION- No.PHD-1125/C.R.199/Japuk (29).—In exercise of the powers of Central Government under section 25 of the Negotiable Instruments Act, 1881 (XXVI of 1881) entrusted to it by the Government of India, Ministry of Home Affairs vide its Notification No.39/1/68/JUDI-III/dated the 8th May, 1968, the Government of Maharashtra hereby declares the following days as Public Holidays in the State of Maharashtra during the calendar year 2026.

## Bombay Chamber webinar highlights urgent DPDP compliance needs

Mumbai: The Bombay Chamber of Commerce and Industry, through its Legal & IPR Committee, convened a high-level webinar on the Digital Personal Data Protection (DPDP) Act and the newly notified rules. The programme brought together leading legal experts and industry representatives to explore the legislation's wide-ranging impact and to share practical insights on how businesses can adapt to an evolving regulatory environment. Held on December 05, 2025, the session clarified the compliance requirements organisations must meet within the 18-month transition period.
