# INAUGURAL SESSION



## Introductory Remarks

### **Mr. Sudhanshu Vats, Sr. Vice President, Bombay Chamber & Managing Director, Pidilite Industries Ltd**

An Alumnus of IIM Ahmedabad and NIT Kurukshetra, Sudhanshu has a career spanning 33 years across sectors with a strong track record of propelling significant business growth and creating long-term value for all stakeholders of the company. He is an inspirational leader and mentors many young CEOs and CXOs, some of whom started their careers with him. Before joining Pidilite, he was the Managing Director and CEO at EPL Limited (formerly Essel Propack Limited). Under his leadership, the company grew in double digits and developed a well-articulated strategy of “Leading the Pack” with Sustainability at its core.

As the Managing Director and Group CEO of Viacom18 Media Private Limited, he transformed the company into the fastest-growing full-play media organization with strong Digital footprint, expanding its presence across multiple screens and platforms. Viacom18 quadrupled its top line to \$ 600 m with consistently positive PAT delivery in this period.

Sudhanshu began his professional journey as Management Trainee at Hindustan Lever (now Hindustan Unilever) in 1991, where he spent 20 years across Sales & Marketing and General Management roles shaping, and elevating popular household brands like Lipton, Surf Excel, Rin, Wheel, Dove, Lifebuoy and Lux. He successfully launched Domex, Lipton Iced Tea, and Comfort in the Indian market. In his last role at Unilever, as Vice President - Laundry South Asia and Global Vice President - Radiant (Rin Brand), Sudhanshu grew these businesses by 20%+ crossing the € 1 Billion milestone. During 2004-2005, Sudhanshu worked with BP in India as VP Marketing, Castrol India Limited and successfully relaunched the Castrol Master Brand.

Sudhanshu is the Senior Vice President and Director on the Board of Bombay Chamber of Commerce and Industry. He is the Co-Chair of National FMCG Committee of CII. He is the Director and Vice President of ASCI. He is also on the Global Advisory Board of Columbia University, New York. Sudhanshu is an NTSE Scholar (1983). He holds the Governor’s Medal for All Round Best Student at MNSS Rai (1985) and Gold Medal for All Round Best Student at NIT Kurukshetra (1989). Sudhanshu is a Six Star (World Marathon Majors) Sub-4-hour marathon runner. His philanthropic focus is on education. He serves on the advisory board of several NGOs.



## Setting the Theme

### **Shri. Rajiv Jalota, Former IAS, Former Chairperson, Mumbai Port Authority and Chairman of the Conference**

Rajiv Jalota is a Master of Science in Chemistry from Lucknow University and a Masters in International Development Policy from Sanford School of Public Policy, Duke University, USA. He joined Indian Administrative Service in 1988 and superannuated, as Chairperson, Mumbai Port Authority in the rank of Secretary to GoI, in September 2024. Rajiv belongs to Maharashtra cadre of IAS and worked as CEO of Zilla Parishad, Osmanabad; District Collector of Yavatmal and Latur districts in his initial years.

On his return from USA, Rajiv worked as Managing Director, SICOM followed by a full stint as Chief Executive Officer of Maharashtra Industrial Development Corporation (MIDC). He also served as Commissioner of Employment and Self Employment of Maharashtra State, before joining the Municipal Corporation of Greater Mumbai as Additional Municipal Commissioner (Projects). In the Municipal Corporation Rajiv handled Finance and Budget, Slum Sanitation Water Supply and Sewerage Management and Assessment and Collection Department. He introduced the Capital Value System in Property Tax in Mumbai. Rajiv worked as Commissioner, Sales Tax (followed by GST) for Maharashtra from January 2015, and was part of National Law and Policy making process of GST till he demitted office in 2020. He successfully implemented GST in Maharashtra State. Rajiv was awarded with the PM Award for excellence in Public Administration in 2017 as part of a group, which worked for bringing GST to reality. He was also responsible for managing the Corona Control Room of Maharashtra State. Rajiv headed the Higher and Technical Education department of Maharashtra State, wherein he was involved in preparing the Implementation Plan of National Education Policy 2020. Rajiv served as Chairperson of Mumbai Port Authority and Indian Ports Association for almost four years. Rajiv was instrumental in developing the largest International Cruise Terminal of the country at Mumbai Port, served as national coordinator for cruise tourism, chaired a Committee for enhancing and improving Urban Water Transport in Mumbai Harbour and represented India in the Quad Shipping Task Force.

**Mr. Arjun Chowgule,

Arjun Chowgule is the Managing Director of Chowgule and Company – the holding company of an industrial conglomerate with interests in commodities, logistics, engineering, trading and education. He oversees finance and technology at a Group level. Arjun holds responsibility for the operations of the shipbuilding and energy engineering business – which is today India's largest private sector shipyard in terms of vessel deliveries.

From a position of a depleted order book, over the last two years these businesses have signed shipbuilding contracts to build the next generation of the global fleet – comprising of orders for hybrid and diesel electric vessels for the European market. In March 2023, the business completed the acquisition of the Mangalore Shipyard – which will increase production capacity 3x. Arjun is the President of the Shipyards Association of India, holding position of Chair at CII Goa, as well as being a member of the Executive Council of Goa University. Previously, he was the Global President of the NxG Leadership Team and a member of the Board of the Family Business Network International. He was also the founding NxG Leader of CII Family Business Network India. Arjun has a BA (Hons.) in Economics from the University of Durham and an MA in Organisation Studies from the University of Warwick. He is a volunteer with the Art of Living.

Shri Shyam Jagannathan, a 1997 batch IAS officer of the Assam Meghalaya cadre, assumed office of the Director General of Shipping under Ministry of ports, Shipping and Waterways, Govt. of India on 03rd July, 2023.

He has earlier served as Zonal Development Commissioner, Santacruz Electronic Export Processing Zone (SEEPZ), Special Economic Zone (SEZ), Mumbai under the Ministry of Commerce and Industry, Govt. of India at Mumbai. In his earlier assignments with the State Government of Assam, Shri Shyam Jagannathan has served as Commissioner & Secretary, Finance Department and Commissioner, North Assam Division. Shri Shyam Jagannathan has also served as Commissioner, Commercial Taxes, Chairman Civil Supplies Corporation, Department of Food & Civil Supplies, Department of Finance, Government of Kerala and separately as District Magistrate of West Garo Hills in Meghalaya, thereby giving him the diverse exposure of the three States of Assam, Kerala and Meghalaya.

He has domain knowledge in the core areas of public finances, export promotion, prospective planning, public policy analysis and sectoral exposure to Animal Husbandry and Veterinary Rural development and judicial processes. Presently, in the assignment of D.G. Shipping, an attempt is being made to leverage technology-based solution to computerize end to end the work flow process of the Directorate General of Shipping and the Examination Reforms for the compliance to the International Convention on Standards of Training, Certification and Watchkeeping for Seafarers (STCW).

Mohanlal Pillai is the Chief Executive Officer (CEO) at Mech Marine Engineers Private Limited. He has a rich background in the design and construction of small and medium-sized crafts, including Tugs, Launches, Tankers, and Dredgers. Mohanlal Pillai is currently involved in the detailed design and production plans for the 40th Bollywood Pulld Boat Tug and has been instrumental in the successful completion of a green field shipyard and the construction of the first 100 M long R0-Pax vessel on Lake Victoria.

He has also been involved in the Tyra Redevelopment project, restarting production facilities with the first molecules of gas fed into the system. Mohanlal Pillai's leadership is expected to further strengthen the company's position in the industry.

Vice Admiral Ankur Sharma NM was commissioned into the Indian Navy in Nov 1989. The officer is a graduate in BE (Electrical) and has pursued his post-graduation in MBA (IT) from Jamnalal Bajaj Institute of Management Sciences. He is an alumnus of National Defence College, where he pursued his M.Phil (Defence Strategic Studies).

During his 33 years of naval career, the officer has accumulated a rich experience through varied appointments in the field of maintenance of maritime systems, Research and Development. He has served onboard numerous frontline Warships, design agencies and Naval Dockyards. His present areas of interests include adaptation of futuristic technologies to maritime domain and synergising commercial cutting edge technologies to battlefield applications. His prominent works include induction of emerging technologies in the field of Weapon and Electronic Systems into the Indian Navy. The officer has been awarded with various prestigious commendations and medals like VCNS Commendation, CNS Commendation, VK Jain Gold Medal and Nausena Medal for path breaking work in the field of maintenance of weapons and sensors. Prior to assuming charge as the Admiral Superintendent, Naval Dockyard Mumbai, the Admiral headed the Weapons and Electronics System Engineering Establishment (WESEE) which is the Indian Navy's Premier R & D Organisation, where he spearheaded induction of critical cutting edge indigenous technologies into our Navy's operations. The officer has played a leading role in developing and thereafter inducting niche indigenous technologies into the navy some of these includes Combat Management Systems which are fitted onboard all IN ships, Software defined radios which are a backbone of naval communication, autonomous platforms, AI based data frameworks etc to name a few. The Admiral took over as the Admiral Superintendent Dockyard of the prestigious Naval Dockyard, Mumbai on 24 Sep 24. The Admiral relinquished duties of Admiral Superintendent Naval Dockyard Mumbai on 26 Nov 25.
